UPDATE TO INVESTMENT MINISTERS ON THE JOINT BORDER MANAGEMENT SYSTEM (JBMS)

Purpose

- 1 This report gives you a progress update on the Joint Border Management System (JBMS) and seeks your agreement to forward the report to the Investment Ministers before their meeting on 20 June 2016 and to the Border Sector Ministers for their information.

Key points from the Update

- 2 Our preferred approach to completing JBMS continues to focus on:
 - Having IBM complete the Trade Single Window (TSW) elements of JBMS.
 - [REDACTED] 9(2)(j)
 - [REDACTED] 9(2)(j)
- 3 We are working with IBM to finalise the scope, planned approach, timeline and acceptable level of quality required for the completion of TSW. [REDACTED] 9(2)(j)
- 4 Timing for the final release of TSW (Release 10) has had to be further extended due to a required security upgrade, with Systems Integration Testing now expected to be completed by 19 August, with "Go-live" date likely to be pushed out into 2017 (i.e. after the trade busy season).
