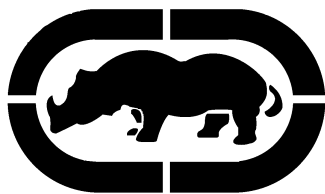

## Customs Rates of Exchange

This notice may be cited as the Customs Exchange Rates Notice (No. 135) in terms of Section 62 to the Customs & Excise Act 1996. This notice shall come into force on the 10th day of December 2001.

Exchange Rates—Where under any provisions of the Customs & Excise Act 1996 an amount is to be taken into account for the purpose of assessing duty or for any other purpose is not an amount in New Zealand currency, the amount to be so taken into account shall be the equivalent amount in New Zealand currency in accordance with the rate of exchange set out in this notice.
