### What are the benefits of being a Secure Export Scheme partner?

- There is no joining fee
- International recognition of exports sent via NZ's secure supply chain.
- Less documentation checks and inspection interventions
- Reduced export entry fees for partners
- Customs people based in 13 international locations help SES members interpret trade agreements, nontariff barriers and help with clearance issues.

### Is there a joining criteria?

Your export volume, export destinations, export growth plans and your commitment to meet the requirements of a secure supply chain will determine whether you are ready to join the scheme.

### How do businesses start the SES application process?

Complete our registration of interest form. We will explain the application process and help you decide if you are ready to submit an application to start the joining process.

### How long does it take?

It will vary depending on the supply chain complexity. The four key areas we will assess are product storage, container packaging, transport, and export loading. We appreciate that NZ traders must prioritise the needs of their core business so we work closely with our applicants to match the pace they set to manage the application process.
