#### Application form: exemption for vessels to enter New Zealand for delivery to a business

Foreign vessels are not permitted to arrive in New Zealand unless they meet one of the exemption criteria specified under clause 10 of the <u>COVID-19 Public Health Response (Maritime Border) Order</u> 2020.

Please complete the following form to request an exemption from prohibition under the Maritime Border Order, **if there is a compelling need for the ship to arrive in New Zealand for the purpose of delivering the ship to a business, which could include for the purpose of repairing and refitting the ship.** 

The vessel will only be allowed into New Zealand if they have been granted permission by the Ministry of Health, and Immigration New Zealand.

Immigration New Zealand has advised the crew cannot enter New Zealand until the vessel applies for and is granted an exemption to the maritime border prohibitions and the crew have applied for and been granted the right visas. If granted an exemption for the vessel from the Director-General of Health, please attach a copy of the exemption approval as proof to support the crew visa applications to Immigration New Zealand.<sup>1</sup>
