Application form: exemption for vessels to enter New Zealand for humanitarian reasons or other compelling needs

Foreign vessels are not permitted to arrive in New Zealand unless they meet one of the exemption criteria specified under clause 10 of the <u>COVID-19 Public Health Response (Maritime Border) Order 2020.</u>

Please complete the following form to request an exemption from prohibition under the Maritime Border Order, **for humanitarian reasons or other compelling needs.**

The vessel will only be allowed into New Zealand if it has been granted permission by the Ministry of Health, and Immigration New Zealand.

Once completed, please email this form to **applyformaritimeexemption@health.govt.nz** with any supporting documents.

Immigration New Zealand has advised that crew cannot enter New Zealand until the vessel applies for and is granted an exemption to the maritime border prohibitions and any crew who require visas have applied for and been granted the appropriate visas.

If granted an exemption for the vessel to enter New Zealand from the Director-General of Health, please attach a copy of the exemption approval as proof to support the crew visa applications to Immigration New Zealand.¹
