1 Title

This order is the Excise and Excise-equivalent Duties Table (Temporary Reduction of Motor Spirits Duty) Amendment Order 2022 Amendment Order 2022.

2 Commencement

This order comes into force at 11.59 pm on 14 June 2022.

3 Principal order

This order amends the Excise and Excise-equivalent Duties Table (Temporary Reduction of Motor Spirits Duty) Amendment Order 2022.

4 Clause 2 amended (Commencement)

In clause 2(2), replace “15 June 2022” with “16 August 2022”.

5 Clause 4 amended (Temporary suspension and reduction of current rate of excise duty and excise-equivalent duty on motor spirits)

In clause 4(1), replace “14 June 2022” with “15 August 2022”.

6 Clause 5 amended (Current rates of excise duty and excise-equivalent duty on motor spirits reinstated on 15 June 2022)

In the clause 5 heading, replace “15 June 2022” with “16 August 2022”.

Explanatory note

This note is not part of the order, but is intended to indicate its general effect.

This order, which comes into force at 11.59 pm on 14 June 2022, amends the Excise and Excise-equivalent Duties Table (Temporary Reduction of Motor Spirits Duty) Amendment Order 2022 to extend the temporary reduction of motor spirits duty until 15 August 2022.

This order is a confirmable instrument under section 122 of the Legislation Act 2019. It is revoked at the close of 30 June 2023, unless confirmed earlier by an Act of Parliament. That stated time is the applicable deadline under section 121 of that Act.
