# 1 Title

This order is the Excise and Excise-equivalent Duties Table (Temporary Reduction of Motor Spirits Duty) Amendment Order 2022.

# 2 Commencement

- (1) This order, except clause 5, comes into force on 15 March 2022.
- (2) Clause 5 comes into force on 1 July 2023.

# 3 Excise and Excise-equivalent Duties Table Amended

This Order amends the Excise and Excise-equivalent Duties Table (the **Table**) made under <u>clause 16(1)</u> of Schedule 3 of the Customs and Excise Act.

# 4 Temporary suspension and reduction of current rate of excise duty and exciseequivalent duty on motor spirits

- (1) In the Table, Parts A and B items relating to fuels, fourth column, the rate of "70.024¢ plus 8¢ per g of Pb" is suspended for the period beginning on 15 March 2022 and ending at the close of 30 June 2023.
- (2) In the Table, Parts A and B, items relating to fuels, fourth column, replace "70.024¢ *plus* 8¢ per g of Pb" with "45.024¢ *plus* 8¢ per g of Pb" in each place.

# 5 Current rates of excise duty and excise-equivalent duty on motor spirits reinstated on 1 July 2023

In the Table, Parts A and B, items relating to fuels, fourth column, replace, "45.024¢ plus 8¢ per g of Pb" with "70.024¢ plus 8¢ per g of Pb" in each place.

# 6 Revocation

This order is revoked on 5 July 2023.
