- A current or recently expired passport bio-page or driver licence (front and back). If your passport or driver licence expired more than 6 months ago, please contact movementchecks@customs.govt.nz before you complete this form.
- Evidence of previous name(s) used during the time covered by your request. You only need to provide this if your name has changed.
