Please find enclosed a complete Working Tariff Document (effective 1 July 2024 that replaces in full your current document). The change that took effect 1 May 2024 was complete reprint, as a result of incorporating the EU-New Zealand Free Trade Agreement, and further changes are taking effect on 1 July 2024 which are listed below:

Tariff (Statistical Requirements) Amendment Notice (No. 1) 2024

This notice amends the statistical key codes and descriptions of the Tariff items specified in the First and Second Schedules of the notice. The First Schedule provides for a request to identify vaping products and products relating to the WCO recommendations for the Basel Convention (waste oil containing PCBs), the Prohibition of Chemical Weapons (specific chemicals and preparations) and the Rotterdam Convention (specific chemical compounds). The Second Schedule corrects some minor description errors. These are denoted by the symbol ‘◆’.

Excise and Excise-equivalent Duties Table (Alcoholic Beverages Indexation) Amendment Order 2024, made on 10 June 2024

The Excise and Excise-Equivalent Duties Table (Alcoholic Beverages Indexation) Amendment Order 2024 comes into force on 1 July 2024. This Order adjusts the excise and excise-equivalent duties on alcoholic products. The adjustment is based on movement in the Consumers Price Index (CPI) for the 12-month period up to 31 March 2024. These are denoted by the symbol ‘▲’.

Excise and Excise-equivalent Duties Table (Reduction for Specified Tobacco Products) Amendment Order 2024, made on 24 June 2024

The Excise and Excise-equivalent Duties Table (Reduction for Specified Tobacco Products) Amendment Order 2024 comes into force on 1 July 2024. This Order amends the Excise and Excise-equivalent Duties Table to provide for more granular classification of the specified heated tobacco products. The Order also gives effect for a temporary reduction of excise and excise-equivalent duty for certain tobacco products for the period starting on 1 July 2024 and ending at the close of 31 December 2024. These changes are denoted by the symbol ‘▼’.

Tariff (Specified Tobacco Products) Amendment Order 2024, made on 24 June 2024

The Tariff (Specified Tobacco Products) Amendment Order 2024 comes into force on 1 July 2024. This Order provides for more granular classification of the specified heated tobacco products and reflects the amendment made by the Excise and Excise-equivalent Duties Table (Reduction for Specified Tobacco Products) Amendment Order 2024. These changes are denoted by the symbol ‘▼’.

Other miscellaneous amendments

There are also a small number of other technical corrections and realignments mainly of a textual nature. These are denoted by the symbol ‘➤’.
