### New foot-and-mouth disease eGate question

Supporting risk management of foot-and-mouth disease at the border, **from 11:55pm Friday 12 August** an additional question will be asked of travellers presenting at an eGate.

Travellers will be asked whether they have been in Indonesia (including Bali) in the last 30 days.

If a passenger answers yes, they will be referred to the Customs Primary booth to speak with a Customs officer.

If a passengers answers no, they can proceed through the eGates.

Please be aware this may result in slower processing for those passengers who have been in Indonesia (including Bali) in the last 30 days.

# Foot-and-mouth disease public messaging

Advertising activities in August and September, including foot-and-mouth disease.

#### WHAT

During August and September, our **usual NZTD messaging** will continue to run, reminding international travellers coming to New Zealand that they need to complete the New Zealand Traveller Declaration.

During August advertising messages for travellers coming to from Indonesia will also include a reminder to get ready for foot-and-mouth disease

**border checks**. This is in response to the increased risk of foot-and-mouth disease in Indonesia, and reinforces the information provided by the Ministry of Primary Industries.

These more targeted foot-and-mouth disease communications may continue after August, depending on the level of risk.

# Foot-and-mouth disease public messaging

#### **WHERE**

General NZTD awareness messages: online advertising, International focus.

Foot-and-mouth disease support messages: online advertising, Indonesia only.

#### WHEN

**General NZTD awareness advertising** starts 11 August 2022 and will run until at least the end of September.

**Foot-and-mouth disease support** advertising starts 11 August 2022 and will run until at least the end of August but may be extended depending on the risk levels.
