# What you currently do for empty shipping containers

- When importing empty shipping containers into NZ for movement of international cargo, they are reported and cleared on a Carrier Inward Cargo Report – ICR.
- Currently a single transaction fee Inward Cargo Transaction Fee (ICTF) is applied to an Inward Cargo Report (ICR) where the report is a Carrier ICR.
- When you submit a Carrier Inward Cargo Report (ICR) with empty containers, you indicate whether it is:
  - 'New' meaning it is when empty containers (new or used) are being permanently imported into NZ. New containers usually require an Import Entry.

#### OR

> 'Used' meaning being used for repositioning or the movement of international cargo.

# What's changing from 1 April 2026

### Introduction of a Customs levy for empty shipping containers

- Currently a single transaction fee Inward Cargo Transaction Fee (ICTF) is applied to an Inward Cargo Report (ICR) where the report is a Carrier ICR.
- From 1 April 2026, there will be an Empty Container Levy for all shipping containers that arrive in NZ empty (for repositioning or the movement of international cargo).
- > The Empty Container Levy will be charged **per-consignment** of empty shipping containers.
  - □ For noting: **Per-consignment** means all the containers of one importer on one Carrier ICR Inward Cargo Report.

## What's not changing

- There is no change to lodgements.
- > You will still indicate whether each container is 'new' or 'used'.
- ➤ The process of submitting them and the clearance processes in Trade Single Window (TSW) remain the same.

## Charging for different levies

From 1 April 2026, the current fees will finish, and there are new levies coming in.

There will be a levy per consignment of Empty Shipping Containers (change area #2) and the International Transhipment Levy (change area #3) per International Transhipment Request.

There are also Low Value Goods levies (change area #1) on both imports and exports and a Commercial Vessel levy (change area #6) on vessels arriving in NZ.

# What is an 'empty' container and when will the levy apply?

#### **Used containers**

From 1 April 2026, a container will be classified as empty and will be charged the Customs levy based on the following:

- When you submit a Carrier Inward Cargo Report (ICR) for empty containers arriving by Sea to be used for movement of international cargo.
- When you insert that it is 'used' on Trade Single Window.
- The levy will be charged per consignment of empty containers.

### **Empty containers that stay on the ship**

- Empty containers won't attract the Empty Container levy (Sea) if an empty shipping container comes into NZ but stays on the ship.
- This means it doesn't get offloaded on to the wharf for repositioning or the movement of cargo and no Carrier ICR is submitted.

### **Damaged containers**

- Amend the ICR if you bring empty containers into NZ to be used for export and one of them is damaged and is now intended to remain in NZ
- An Import Entry should be lodged for the empty shipping container that is staying in NZ (assuming the empty container is worth over NZD\$1,000 otherwise you can submit a writeoff request)
- The Import Entry would be for the container that is damaged and not worth the money to repair.

➤ There is no change to monthly statements and 20<sup>th</sup> month payment terms.

## **Summary**

KEY:
Stays the same
Change

From 1 April 2026, all good fees will be removed, and they will be replaced with levies.

The new empty container levy will apply to all 'empty' shipping containers arriving in NZ by Sea.

#### What you do now

What you need to do from 1 April 2026

No change.

Submit a Carrier Inward Cargo Report (ICR) for empty containers arriving by Sea to be used for movement of international cargo.

You will continue to indicate 'used' in TSW when empty containers are being used for the movement of international cargo.

Currently a single transaction fee – Inward Cargo Transaction Fee (ICTF) is applied to an Inward Cargo Report (ICR) where the report is a Carrier ICR.

No additional action is required from you.

The new levies will be charged perconsignment of empty containers from 1 April 2026.

Monthly payment terms remain the same (on or by 20<sup>th</sup> of month for previous month's levies).
