If you are bringing an animal into New Zealand for sale, breeding, showing or on behalf of a business, please contact a customs broker so they can complete the clearance on your behalf.

You can complete this form by saving a copy to your computer. Information you have filled in can be saved as you go so you don't have to complete it in one session.

You can choose to print and complete this form by hand instead. Use a blue or black ink pen and write in CAPITAL LETTERS.

We require the supporting documents listed below. Documents can be supplied as JPEG, PNG, PDF, or document (.doc or .docx) format. Note, we cannot accept links to drop-boxes or external drives, for example Google Drive.

This may be purchase receipts or invoices.
- ☐ Shipping documents
Air Waybill (air freight), Arrival notice or Consignment Note (couriers).
- ☐ For dogs: veterinary certificates and exempting statutory declaration is required

If you are moving to New Zealand, either for the first time or returning

- ☐ Your passport bio-page
- ☐ Your visa or visa confirmation

If you are currently living in New Zealand
