Rules

Section 1 Title, application, commencement and interpretation

1.1 Title

These rules are the Customs (Inward Report) Amendment Rules 2022.

1.2 Application and purpose of rules

These amendment rules revoke and replace form C1 in the Customs (Inward Report) Rules 2004.

1.3 Commencement

These amendment rules come into force on 30 June 2022.

1.4 Interpretation

1.4(1) In these amendment rules, unless the context otherwise requires—

Act means the Customs and Excise Act 2018

Principal Rules means the Customs (Inward Report) Rules 2004

1.4(2) Unless the context otherwise requires, a term that is used in these amendment rules and defined in the Act but not defined in these amendment rules has the meaning given in the Act.

Section 2 Rules amended

2.1 Amendment to the Schedule of the Principal Rules

2.2 Form C1, as set out in the Schedule of the Principal Rules is revoked and replaced by the Form C1 set out in the Schedule to these amendment rules.

2.3 Rules to Continue in Force

2.3(1) The Principal Rules continue in force, except to the extent they are amended by these amendment rules.
